No.DE/BTC/Per-Rec/HS/121/2015/427, In pursuance of the BTC's letter No.BTC/EDN(HS)-121/2015/43, Dated Kokrajhar the 4th Dec., 2015 and as per power conferred in the Sub-section (2) of the Section (4) of the "Assam Non-Government Educational Institution(Regulation& Management) Act, 2006 and Rule 3 of the Rules, 2007 in the "**Assam Non-Government Educational Institution(Regulation & Management) Rules,2007**" Prior Permission/NOC is hereby accorded to **Radiance School** (Secondary Level), Dimakuchi, District- Udalguri, BTC, Assam, with immediate effect from 1-1-2015 subject to the following terms and conditions:-

1. The order for prior permission shall be valid for 2 years only within which the applicant shall have to complete the construction works on its own land and run the school as proposed.
2. The School/ Jr. College authority shall constitute the Managing Committee as section 12 of the Act.
3. The school authority shall have to fulfill all requirements as required under section 10 for the Act and Rule 7, 8, 9, 10, 11, 12, 13 & 14 of the Rules.
4. The School / Junior College authority shall prepare a Scheme of Management as required under section 14 of the Act and Rule 16 of the Rules.
5. The School authority shall apply for Provisional Registration of the School in Form-11 within a period of 2 years along with copies of all documents.
6. In case of failure to complete the task within the specified period of 2 years, this order shall stand cancelled.
7. The Term and Condition laid down in the Assam Non - Government Educational Institution (Regulation & Management) Act, 2006 and Rule, 2007 is to be followed.


