This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

<b>Sl. No.</b>	<b>The school is directed to ensure that :</b>
1	The total number of sections of the school from class I to XII shall be restricted to <b>14</b> , out of which the school can run not more than <b>2</b> sections in secondary classes i.e. <b>1</b> in class IX and <b>1</b> in class X and not more than <b>4</b> sections in senior secondary classes i.e. <b>2</b> in class XI and <b>2</b> in class XII, subject to the condition that the school shall not run more than <b>1/4</b> and <b>1/3</b> of the total sections running in the school at any point in time at the secondary level and senior secondary level, respectively. The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above. Further, increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye law and availability of land and class rooms of greater than 500 sq ft dimension.
2	The optimum number of students intake preferably shall be restricted as per the provisions of the Affiliation Bye Laws, 2018 as per the size of classrooms mentioned below:

1	Greater than and equal to 500 sq ft.	21	40

3	The approval is based upon the documents /data/information uploaded by the school online. The Manager and Principal of the school shall be held responsible for its genuineness. In case of any document found to be fake/forged/fabricated/tampered, the application of the school is liable to be rejected and the school shall be liable for imposition of any of the penalties and necessary action will be initiated against the school as deemed fit, under clause 10.1.16 of Affiliation Bye Laws, 2018.
4	The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
5	The School is required to apply online for extension of affiliation in the preceding academic session before its expiry along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
6	The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e <a href="http://cbse.nic.in">http://cbse.nic.in</a> for updates.
7	The school shall renew mandatory certificates from time to time.
8	The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
9	Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
10	The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
11	The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
12	The School is directed to run at least 01 section each of bal-vatika I, II & III in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
13	The school shall conduct training of its teachers with concerned COE.
14	The school is directed to ensure that all essential valid documents are available under the head Mandatory Public Disclosure (as per annexure– IX) on school's website at all time and the link of certificates should be remain functional.
15	As per the recommendation of NEP, the school shall ensure the participation of its students in the Structured Assessment for Analyzing Learning(SAFAL), an exam conducted by the Board every year. This exam, designed to assess and enhance students' learning, is a valuable initiative for their holistic development, as per the guidelines issued by the Board vide circular no: Acad-49/2024 dated 26 June 2024.

16	The school will ensure the Holistic Progress Card (HPC) is used for the foundational stage according to the guidelines issued by the Board via notification no. CBSE/Director (Acad.-Assessment)/2023 dated 27.12.2023.
17	The school shall submit an undertaking to upload all requisite information regarding students, teachers, and infrastructure details available in the school on the UDISE and OASIS Portals. The registration of the students in classes IX/XI shall be conditional on the school providing complete information on the UDISE and OASIS Portals.
18	The school shall ensure that all teachers undergo at least 50 hours of Continuous Professional Development (CPD) every year, vide notification no. 16/2021 dated 24.09.2021, out of which 25 hours should be from concerned COE.
19	The school may make provision to establish rain water harvesting system in their school premises as per Board's circular no. CBSE/AFF./AC/RWH/2025 dated 24.03.2025.
<p><b>Further, the school shall submit compliance on the following mentioned conditions within 03 months on the SARAS Portal from the date of the grant letter i.e. upto 14/10/2025. Failure to submit compliance within the stipulated time shall invite financial penalty of Rs. 50,000/- and appropriate action may be initiated as deemed fit.</b></p>	
20	The inspection committee has reported that school has 15 classrooms of size greater than or equal to 500 Sq.Ft. As school will left with insufficient number of classrooms for Bal Vatikas, after grant of upgradation up to Senior Secondary level, school shall construct more classrooms of requisite size for accommodating classes for Bal Vatikas, within 03 months and submit compliance with videography.
21	Height of the concrete boundary wall build around the school is not 06 feet. Temporary arrangement has been made by the school by putting tin-sheet above the constructed concrete wall (video reference time1:42). School shall increase the height of the boundary wall up to the height of 06 feet all around the school within 3 months and submit compliance on SARAS with videography.
22	Composite Science lab has not been established as per Board's SOPs and has some deficiencies. Lab has plastic lounge chairs, which is not appropriate furniture for the lab and should be replaced with sturdy furniture (wooden stools). Safety measure i.e. exhaust fans have not been installed. Wooden sealing/roof is seen in the lab, which is a fire hazard. School has to take necessary steps to make the lab fire resistance. School shall accordingly upgrade the lab, as per SOPs, within 03 months and submit compliance with videography.
23	The mathematics lab seems to be temporarily established without appropriate furniture for the lab. Two tables along with few plastic lounge chairs have been arranged in the lab, which are not of much use. No storage facility for storing lab material is seen. The Maths lab needs to have appropriate furniture, more kits, teaching aids, student activity material and manipulative along with proper storage facility and seating arrangements. School shall upgrade the lab as per Board's SoPs within 03 months and submit the compliance with videography.
24	Computer Lab is under sized and not sufficiently equipped. School has less number of computers as specified in SoP issued by the Board vide Circular No.11 dated 04.10.2022. Inspection committee has reported that school has 25 computers only, however, as per norms; school should have at least 40 computers. School shall increase the number of computer to minimum 40, within 3 months and submit compliance on SARAS with videography.
25	Library is under sized. Further, separate reading area for teachers is also not seen in the library. School shall upgrade the same as per board's SOP within 3 months and submit compliance on SARAS with videography.
26	The school does not seem to have referred to RPwD Act and guidelines of the Board for CwSN toilets. Regular cubicles have been converted into CwSN toilets.

which are too small and narrow for free movement of wheelchair/walker. As per board's circular no. 11/2024 dated 09.08.2024, separate CwSN toilets for girls and boys should be maintained on the ground floor of the school building. If classes are conducted on any floor other than the ground floor, separate CwSN compliant toilets for boys and girls with adequate space for the Wheelchair / Walker must mandatorily be maintained on those floor(s) as well. School shall comply with the revised guidelines for CWSN as per Circular No. 11/2024 dated 09.08.2024, within 03 months and submit the compliance with videography.

27 Proper permanent signages have not been fixed at the prominent areas such as entrance of labs, library, toilets and other facilities. School has pasted paper printouts, instead of permanent signage. School shall fix the permanent signages on all prominent area i e. classrooms, labs, library, toilets etc., within 3 months and submit compliance on SARAS with videography.

In case of partial acceptance of compliance, the school shall submit the remaining compliance's within further stipulated period of 03 months. In case of the failure of the school to submit the final compliance's, the Board may enhance the penalty amount and debar the school from filling up the Registration/LOC details of students of classes IX & X, as the case may be, in the next academic session i.e. **2027-28**.
